INTERNACIONALIZACIJA

Univerzitet „Union” u Beogradu (UUB) je posvećen uspostavljanju, negovanju i unapređenju međunarodne saradnje, koja uključuje zajedničke aktivnosti s univerzitetima iz inostranstva, kao i saradnju s međunarodnim organizacijama koje deluju na polju obrazovanja.

Ovom saradnjom UUB stremi da doprinese naučnom i kulturnom povezivanju i razumevanju, da unapređuje znanja i veštine svojih profesorki i profesora, istraživačica i istaživača, studentkinja, studenata, i zaposlenih, kao i da osnažuje akademsku zajednicu u Srbiji. Smatramo da internacionalizacija prostora visokog obrazovanja stvara dinamičnu, inovativnu, integrativnu i otvorenu akademsku zajednicu, koja može da se nosi s izazovima savremenog društva i privrede. INTERNATIONALISATION

Union University in Belgrade (UUB) is committed to establishing, nurturing and advancing international cooperation, which includes the implementation of joint activities with foreign universities, as well as cooperation with international organisations focusing on education.

Through such cooperation, UUB has been striving to contribute to scientific and cultural ties and understanding, advance the skills and knowledge of its professors, researchers, students and staff, as well as strengthen the academic community in Serbia. We believe that the internationalisation of high education creates a dynamic, innovative, integrative and open academic community, capable of coping with the challenges of modern society and economy. It is also a good way to measure ourselves (against others).

UUB is particularly committed to building cooperation networks with educational institutions within the European Higher Education Area and the region. One of our main priorities is to forge regional ties with a view to celebrating our shared European heritage of civic values and a good society – perceived through the lens of intercultural exchange. UUB holds the Erasmus Charter for Higher Education (ECHE), which enables universities to participate in EU high education programmes.

We have supported many professor and student mobilities through the Erasmus+ programme. Our professors have also been participating in European COST Action projects.

In addition, many of our professors have studied or lectured at foreign universities, participated in scholarly events abroad and built networks strengthening international cooperation.

UUB is also committed to strengthening the exceptionality of instruction and engaging leading foreign professors as visiting professors, with a view to ensuring that our students are exposed to a truly international learning experience.

ORGANI I UPRAVLJANJE UNIVERZITETOM

Savet (organ upravljanja) ima 19 članova, od kojih 15 biraju fakulteti, dok se četiri imenuju iz redova studenata. Među najvažnijim poslovima Saveta su: donošenje statuta Univerziteta, na predlog Senata; davanje saglasnosti na statute fakulteta; izbor i razrešenje rektora i prorektora; donošenje finansijskih planova, na predlog Senata; usvajanje izveštaja o poslovanju i godišnji obračun, na predlog rektora; usvajanje plana korišćenja sredstava za investicije, na predlog rektora; donošenje odluka o strateškom planiranju i dr. Mandat članova Saveta traje četiri godine.

Rektor (organ poslovođenja) zastupa i predstavlja Univerzitet i stara se o zakonitosti rada Univerziteta. Po položaju je i predsednik Senata. Rektor potpisuje diplome koje izdaje Univerzitet i fakulteti u njegovom sastavu (zajedno sa dekanom fakulteta na kojem je diploma stečena); rukovodi postupkom promovisanja doktora nauka i doktora umetnosti; izvršava odluke Saveta i Senata, kao i finansijski plan; predlaže Savetu i Senatu donošenje opštih i pojedinačnih akata za koje nije predviđeno da ih predlaže drugi organ; donosi pojedinačne akte kojima se rešava o pravima, obavezama i odgovornosti zaposlenih na Univerzitetu, ako nije predviđeno da o tome rešava drugi organ i dr. Rektorov mandat traje tri godine i može još jednom uzastopno biti biran.

Senat (stručni organ) čine dekan i fakulteta i predsjednik Studentskog parlamenta. Senat odlučuje o pitanjima vezanim za realizaciju i samovrednovanje nastave, naučnog, istraživačkog i umetničkog rada i o drugim pitanjima određenim zakonom i Statutom. Senat utvrđuje predlog Statuta Univerziteta, predlog kandidata za izbor rektora, predlog finansijskog plana i izveštaja o poslovanju, i razmatra godišnji obračun Univerziteta; bira profesora emeritusa; vrši izbor nastavnika Univerziteta koji zasnivaju radni odnos sa Univerzitetom, kao i nastavnika fakulteta u sastavu Univerziteta, a na predlog nadležnih organa fakulteta; predlaže Savetu mere strateškog planiranja razvoja Univerziteta; donosi studijske programe; donosi odluke o međunarodnoj saradnji i dr.

Studentski parlament čine predstavnici studentskih parlamenata fakulteta u sastavu Univerziteta, i to po tri predstavnika svakog od studentskih parlamenata. Studentski parlament preko svojih predstavnika u stručnim organima i telima Univerziteta učestvuje u odlučivanju o pitanjima koja se odnose na osiguranje kvaliteta nastave, reformu studijskih programa, analizu efikasnosti studiranja i utvrđivanja broja bodova. Pored toga, Studentski parlament bira i razrešava studenta prorektora, kao i predstavnike studenata u organima i telima Univerziteta, u kojim su zastupljeni predstavnici studenata. Mandat članova Studentskog parlamenta traje dve godine.

UNIVERSITY BODIES AND MANAGEMENT

Council – Management Body

The Council has 19 members, 15 of whom are appointed by the faculties and four are appointed from amongst students. The Council is notably charged with: the adoption of the University Statute on the proposal of the Senate; approval of Faculty Statutes; appointment and dismissal of the Rector and Pro-Rector; adoption of financial plans on the proposal of the Senate; adoption of annual operational reports and revenue statements on the proposal of the Rector; adoption of investment plans on the proposal of the Rector; adoption of decisions on strategic planning, et al. Council members are appointed to four-year terms in office.

Rector – Executive Officer

The Rector acts for and on behalf of the University and is responsible for the lawfulness of its operations. The Rector is the *ex officio* Chair of the Senate. The Rector signs the diplomas issued by the University and its Faculties (together with the Deans of the Faculties at which they are acquired); manages the award of doctoral diplomas; implements Council and Senate decisions, as well as financial plans; proposes to the Council and the Senate the adoption of general and individual enactments not within the remit of other bodies; adopts individual enactments on the rights, obligations and responsibilities of University staff not within the remit of other bodies, et al. The Rector is appointed to a three-year term in office and may be re-elected once.

Senate – Professional Body

The Senate comprises the Deans of the University Faculties and the Chair of the Student Parliament.

The Senate decides on issues related to the implementation and self-evaluation of instruction, scientific, research and artistic work, and other issues defined by law and the Statute. The Senate drafts the University Statute, nominates candidates for the position of Rector, drafts financial plans and operational reports and reviews the University's annual revenue statements; appoints Professors Emeriti, new teachers employed by the University and teachers employed by the faculties on the proposal of the relevant Faculty bodies; proposes to the Council strategic development planning measures; adopts study programmes; adopts decisions on international cooperation, etc.

Student Parliament

The University Student Parliament comprises of three representatives of each of the student parliaments of UUB faculties. Via its representatives in UUB bodies, the Student Parliament participates in decisions on issues related to instruction quality assurance, curricular reform, study efficiency analysis and ECTS credits. In addition, the Student Parliament appoints and dismisses the Student Pro-Rector and student representatives in UUB bodies that include student representatives. Student Parliament members are appointed to two-year terms in office.

NASTAVNICI I SARADNICI

Na realizaciji studijskih programa je angažovano 154 nastavnika i 67 saradnika. Od nastavnika, 48 je u zvanju redovnog profesora, 43 u zvanju vanrednog profesora, i 46 u zvanju docenta. Angažovana su i tri profesora emeritusa, šest nastavnika stranog jezika, jedan nastavnik veština i sedam gostujućih profesora. Kada je reč o saradnicima, ukupno je angažovano 67 osoba, od kojih 27 saradnika u nastavi, 33 asistenta, šest istraživača i jedan lektor.

Nastavni proces se prilagođava potrebama i izazovima savremenog društva. Fakulteti podržavaju nastavno osoblje u stalnom razvoju i usavršavanju, kako u cilju unapređivanja nastavničkih sposobnosti, tako i za potrebe njihovog naučnog rada. Univerzitet se strogo pridržava propisanih kriterijuma za napredovanje nastavnika.

Naučne i stručne kvalifikacije nastavnog osoblja odgovaraju obrazovno naučno-umetničkom polju. Ocena naučnoistraživačkog, stručnog i profesionalnog rada vrši se na osnovu objavljenih radova, realizovanih projekata, rezultata praktičnog rada i dr. Posebna pažnja se pridaje podsticanju doprinosa akademskoj i široj društvenoj zajednici. To je sve doprinelo da nastavnici fakulteta u sastavu Univerziteta „Union” budu visoko kompetentni i kvalifikovani da predaju na svim nivoima studija koji se realizuju. Nastavnici i saradnici su dostupni studentkinjama i studentima kako na nastavi, tako i van nje.

Vreme na nastavi i vežbama se koristi delotvorno, u duhu tolerancije i saradnje. Sprovođenjem metoda aktivnog učenja putem diskusije, rešavanja problema, simulacije, pisanja i učenja na osnovu iskustva – na najbolji način se ostvaruju ciljevi časa i ciljevi svakog pojedinačnog predmeta. Rad u nastavi ceni se na osnovu evidencionih podataka koje vode fakulteti. Ocena pedagoškog rada ceni se kroz rezultate studentskih anketa. Mišljenja koje studentkinje i studenti iznesu u anketama se dalje koriste kako bi se unapredila nastava i nastavna sredstva.

Osim u nastavi, nastavno osoblje učestvuje i u:

- naučnoistraživačkim projektima Fonda za nauku Republike Srbije kao i Ministarstva prosvete, nauke i tehnološkog razvoja, ali i drugih ministarstava;
- naučnoistraživačkim, umetničkim i razvojnim projektima koji se finansiraju iz programa EU;
- stručnim, umetničkim i razvojnim projektima koje finansiraju domaće i inostrane kompanije i organizacije;
- projektima koji su rezultat međunarodne saradnje među državama, visokoškolskim ustanovama i međunarodnim organizacijama i specijalizovanim agencijama.

Nastavnici i saradnici fakulteta u sastavu Univerziteta često su angažovani kao konsultanti ili kao članovi ekspertske grupe u oblasti za koju su izabrani, imaju samostalne ili kolektivne izložbe u zemlji i inostranstvu. Neki od njih predaju na univerzitetima u inostranstvu i članovi su međunarodnih ekspertske timova.

PROFESSORS AND ASSOCIATES

Union University's study programmes are delivered by 154 professors and 67 associates. Forty-eight of the teachers are Professors, 43 are Associate Professors, 46 are Assistant Professors, three are Professors Emeriti, six are Foreign Language Teachers, one is a Lecturer of Professional Skills and seven are Visiting Professors. Of the 67 associates, 27 are Teaching Assistants, 33 are Assistants, six are Researchers and one is a Language Editor.

UUB's teaching process is tailored to the needs and challenges of present-day society. The faculties support the teaching staff's continuous professional development, with a view to both improving their teaching skills and facilitating their scientific endeavours. The University strictly complies with the prescribed professorial promotion criteria.

The teaching staff possesses the requisite scientific and professional qualifications. Their scientific, research and professional work is assessed based on the papers they published, projects they implemented, practical work results, et al. Particular attention is devoted to motivating them to contribute to the academic and broader community. UUB teachers are thus highly competent and qualified to implement study programmes at all levels. UUB professors and associates are readily available to the students both during and outside class. Class and exercise time is used effectively, in the spirit of tolerance and cooperation.

Active learning methods include discussions, problem solving, simulation, writing and experiential learning – the best ways to achieve the goals of the lessons and of each individual course. The professors' performance is evaluated based on records kept by the faculties. Their teaching skills are evaluated through student surveys. The students' feedback is used to improve teaching and teaching methods. In addition to teaching, our professors are also involved in:

- scientific and research projects of the Serbian Science Fund, the Ministry of Education, Science and Technological Development, as well as other ministries;
- scientific, research, art and development projects funded from EU programmes;
- professional, art and development projects funded by Serbian and foreign companies and organisations;
- projects that are the result of international cooperation between states, universities, international organisations and specialised agencies.

Many UUB professors and associates serve as consultants or members of expert groups in their area of expertise, while some exhibit their artistic works or participate in collective exhibitions in Serbia and abroad. Some of our professors also teach at foreign universities and are members of international expert teams.
